Landsec takes its fire safety duties seriously, and we are committed to:

- Maintaining a robust fire risk management system based on BS 9997, and be certified to that standard by a UKAS accredited certification body
- Complying with all relevant legal and other statutory third party requirements
- Continually improving our fire risk management system and performance. We will achieve these commitments through the following means:
- The systematic identification of fire hazards present and the application of a fire risk management strategy that will identify and implement appropriate control measures
- The maintenance of a set of objectives through consultation and management review, and a supporting programme of work that is focused on achieving its commitments and eliminating or reducing the major hazards present
- The clear definition of individual management and employee responsibilities for implementing the fire risk management system and achieving the Company's commitments
- The provision of appropriate consultation, participation, information, instruction, training, and supervision so that all employees:
 - Are actively involved in fire risk management of the company;
 - Are aware of their responsibilities and legal duties; and
